Entry

Enter a drawing for a chance to win a \$1,000 donation to the GiveBig charity of your choice. Enter by donating funds via the Seattle Foundation's GiveBig website and selecting "BECU" under the "I am an employee or member of an organization that matches gifts" drop down field. A donation through GiveBig is required to win.

Limitations

The selected charities will be the charity of your original donation and must comply with BECU's giving guidelines. Winners must be legal residents of the United States and 18 years or older. Employees or agents of BECU, its affiliates, subsidiaries, advertising/promotional agencies, vendors, and the members of their immediate families or those persons living in the same household of such individuals are eligible to enter or win. All federal, state and local laws and regulations apply. Void where prohibited by law.

Giving Guidelines

At BECU, our charitable giving is generally directed to institutions that are recognized by the US Internal Revenue Service (IRS) as a charitable organization under Section 501(c)(3) of the IRS Code. BECU reserves the right to determine and amend which organizations are eligible to receive charitable support from BECU. In no event will BECU provide charitable support to organizations that do not comply with the USA Patriot Act. Organizations seeking charitable support from BECU must generally certify to BECU that their charitable and/or educational programs and services are offered and provided to the intended beneficiaries of such programs and services without discrimination on the basis of race, color, national origin, ancestry, sex, age, religion, physical or mental disability, medical condition, veteran status, marital status, pregnancy, sexual orientation, gender identity, genetic information, or any other classification protected by applicable local, state, or federal laws. BECU does not contribute to organizations in which religious practice is required for selection and/or receipt of charitable services.

Properly accredited public and private educational institutions are eligible and include primary, secondary, and degree granting colleges, universities, and schools.

Social service or community programs provided by religious or faith-based organizations when the following conditions are met:

- The group is a registered US-based 501(c)(3) non-profit organization.
- Programs have a formal mission statement and separate program budget.
- The group offers secular programs or services to eligible participants without regard to their faith

or willingness to participate in religious activities.

- The group ensures that company contributions do not fund religious activities such as worship or proselytization.

Ineligible organizations include:

- Gifts or payments to political organizations
- Gifts to religious or sectarian programs for inherently religious purposes (including but not limited to religious worship or proselytization)
- Gifts to churches, synagogues, mosques, ministries, other houses of worship, or religious organizations, unless for specific social programs that meet the criteria identified above.
- Gifts made to individuals or their travel expenses, pledges, titles, tuition, dues, or subscriptions

BECU reserves the right to amend, modify, or terminate this program at any time without notice.

Winners

The five winners will be randomly selected by a drawing conducted on May 24 at 10:00 am from all entries received from 12:01 am on April 26 through May 9 11:59 pm and you need not be present to win. Odds of winning based on the number of entries received. The winners will be notified by mail or phone no later than the end of business May 31 and will have 15 business days from date of notification to contact BECU, complete the claim form and other documents as necessary, and provide them to BECU. Should a winner fail to comply with these requirements or otherwise be unable to accept the prize, the winner will forfeit the prize and it will go to the first selected alternate.
